**GENERAL RELEASE.**

I have voluntarily applied to participate in the activities of the San Diego Fly Fishers, a California nonprofit public benefit corporation. I am voluntarily participating in these activities with knowledge of the potential danger involved.

Therefore, I hereby release and forever discharge San Diego Fly Fishers, its officers, directors and/or members, from any and all actions, suits, debts, claims, demands and obligations of any kind or nature, whether known or unknown, both in law and in equity, I ever had, now have or may have against them upon or by reason of any matter, cause or thing. I acknowledge and agree this release applies to any and all actions, suits, debts, claims, demands and obligations, whether known or unknown, foreseen or unforeseen, patent or latent, that I may have against San Diego Fly Fishers, its officers, directors and/or members. I hereby waive the provisions of California Civil Code section 1542, which I have read and which states as follows:

A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor.

I understand and acknowledge that the significance and consequence of this waiver of California Civil Code section 1542 is that even if I should eventually suffer additional damages, I will not be able to make any claim for those damages against San Diego Fly Fishers, its officers, directors and/or members. Furthermore, the parties acknowledge they intend these consequences, even as to claims for damages that may exist as of the date of this release, but which the parties do not know exist, and which, if known, would materially affect the parties' decision to agree to this release. This is true whether the parties' lack of knowledge is the result of ignorance, oversight, error, negligence or any other cause.

A. The parties acknowledge and represent that, in agreeing to this release, they have not relied on any inducements, promises or representations made by the other party.

B. The parties further acknowledge and warrant their agreement to this release is free and voluntary.
